The debentures are secured by first pari passu charge on movable and immovable properties of the company along with lender banks. The restructuring package under CDR scheme was approved on 01.06.2012.</p> <p>We as trustees have continuously followed up the matter with the company for payment of the defaulted amount due to debenture holders. The instructions were also sought from the investors for the legal course to be adopted for the recovery. We have conducted the meeting of Debenture Holders and Issuer Company on 12.09.2013 for deciding further course of action. In the said meeting, LIC expressed its willingness to accept the funding of interest provided the company agrees to increase the rate of interest from 10% to 11% which is at par with the other lenders. Company has taken up the matter with SBI to consider the same. Debenture holder viz. LIC is following up with SBI. The issue of LIC & GIC joining the CDR Scheme is under correspondence between LIC, GIC, Issuer Company and Lender banks. So far there are no specific instructions from LIC / GIC for taking any legal action against company.</p> <p>The matter is followed up with debenture holders i.e. LIC & GIC vide letters dt. 20.09.2016 to inform the current status. While GIC has not responded, LIC has asked for the details of properties mortgaged as security, which are given on 12.10.2016. The details of steps taken by it are awaited.</p>
