The debentures are secured by first pari passu charge on movable and immovable properties of the company along with lender banks. The restructuring package under CDR scheme started from June, 2012 have not yeilded any positive results. Despite continuous follow-up with the debenture holders viz. LIC and GIC, there are no specific instructions from LIC / GIC for taking any legal action against company. On 24.05.2017, a meeting of debenture holders was held by DT. It was decided to initiate action for recovery of the dues by filing application with DRT. Necessary administrative sanction is being obtained by the respective NCD holders and on receipt of the same by DT, further action will be taken.
