- 1) The Company is a Non-Banking Financial Company registered with the Reserve Bank of India.
- 2) The audited financial results for the year ended 31 March 2018 have been reviewed by the Audit Committee and recommended for adoption to the Board of Directors. The Board of Directors of the Company have considered and approved the same at its Meeting held on 09 May 2018.
- 3) The Statutory Auditors have carried out audit of the annual financial results as required under Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and have issued an unmodified opinion thereon.
- 4) Figures for the half year ended 31 March 2018 and 31 March 2017 are the balancing figures between audited figures in respect of full financial year and the published year to date unaudited figures for the half year ended 30 September of the respective financial years. The figures considered for the half year ended 30 September 2016 are as certified by the management which is not subjected to an audit or review.
- 5) The Company provides asset or working capital loans to Micro and Small businesses and has classified this as its business segment. There is no other separate reportable segment as per accounting standard (AS) 17 on segment reporting.

- f) During the half year ended 31 March 2018, the Company has issued 1,684,474 Class A1 Equity Shares of Rs.10 each for cash pursuant to private placement as per Companies Act, 2013 at Rs.415.56 per share aggregating to Rs.700,000,015 (including share premium). This resulted in an increase of Rs.16,844,740 in Share Capital and Rs.655,471,498 in Share premium account, net of share issue expenses.
- g) The Company has given an interest and collateral free loan to Visage Trust to provide financial assistance for purchase of equity shares of the Company. The Company has established the Visage Trust to administer Employee Stock Option Plan (ESOP) to which the shares 370,900 (Previous year 265,900) were issued. These shares will be subsequently issued to the employees pursuant to ESOP Plan. The amount recoverable from the Visage Trust has been reduced from share capital to the extent of the face value as per the requirement of the Guidance note on share based payment issued by Institute of Chartered Accountants of India (ICAI).

- h) The Company has followed same significant accounting policies in the preparation of the financial results as those followed in the annual financial statements for the year ended 31 March 2017 except for the below:
- During year ended 31 March 2018, the Company had revised useful life of its computer software (loan management software) from 3 years to 6 years based on the internal technical evaluation carried out by the Company. Accordingly depreciation for the current year ended 31 March 2018 has been charged based on revised useful life. Had the Company followed the earlier useful life, the amortization cost would be higher by Rs. 1,430,284.
- i) Net Profit after Tax of the Company for the current half year ended 31 March 2018 and year ended 31 March 2018 are 85.36,948,656 and Rs. 46,107,965 respectively.
- j) Net worth of the Company (As per section 2(57) of the Companies Act, 2013) as at 31 March 2018 Rs. 969,724,859.
- k) Earning per share for the half year ended 31 March 2018 and 31 March 2017 have been calculated for six months and not annualised.
