We have filed Claim Form C with the IRP on behalf of the Debentureholders for an amount of Rs.6,09,25,089/-(Rupees Six Crores Nine Lac TwentyFive Thousand Eighty Nine Only) which comprises of principal of Rs.5,10,000/-(Rupees Five Crores Ten Lacs Only) and pending interest of Rs.99,25,089/- (Rupees Ninety Nine Lac Twenty Five Thousand Eighty Nine Only). This claim has been admitted by the IRP and we have been included as a creditor in the COC on behalf of the debentureholders. The debentures issued were listed and unsecured.	After defaulting the payment of interest and principal amount in July, 2017, all necessary actions have been taken from time to time and the present status is as follows:  1)The Recovery Officer passed an order of attachment of immovable properties mortgaged to DT on 27.11.2018. The said order is being served on Mr. D.S. Kulkarni, Chairman of DSK, through the Superintendent (Officer in Charge) of the Yerwada Central Jail, since he is under judicial custody.  2) The matter is now fixed on 16.01.2019 to note the status of service of notice of the order and further action.  3)As per the Order of Attachment dated 27.11.2018, issued by the DRT, Pune, all the immovable properties mentioned in the said order have been attached by the Recovery Inspector, DRT, Pune, on 29.01.2019. The Boards to that effect have been fixed on conspicuous parts of the said properties.  4)The valuer for valuation of the attached properties has been appointed by the Recovery Officer, DRT. The Valuer will submit Valuation Report to DRT & the matter is now fixed on 20.06.2019.	During the insolvency proceedings initiated against the company, Insolvency Resolution Professional (IRP) has been appointed. Corporate Insolvency process started from June 6, 2017. The IRP is conducting meeting of the Committee of Creditors (CoC) and it is learnt that the debenture holders viz. LIC & GIC are attending the meetings, since it is learnt from the IRP that the CoC comprises only of the Financial Creditors. Progress from debenture holders is awaited. Resolution plan was approved in CoC meeting and same is pending for approval from NCLT as the empoyees and directors of BDIL have taken objection for the same and NCLT allowed ARCS Ship Builders Services Private Ltd. and others to submit resolution plans. NCLT has not approved resolution process and ordered for liquidation of company & appointed liquidatoron 14.01.2019. Debenture holders will submit their respective claims to the liquidator.
