The Company has adopted first financial statements under Indian Accounting Standards ('Ind AS' notified under Section 133 of the Companies Act, 2013 (the "Act") read with the Companies (Indian Accounting Standard) Rules 2015 as amended by the Companies (Indian Accounting Standard) (Amendments) Rules 2016 for the year ended March 31, 2019. For periods up to and including the year ended March 31, 2018, the Company prepared its financial statements in accordance with accounting standards notified under Section 133 of the Companies Act, 2013 read together with paragraph 7 of the Companies (Accounts) Rules, 2014 (Indian GAAP or previous GAAP). Accordingly, the Company has prepared financial statements which comply with Ind AS applicable for periods ending on March 31, 2018. In preparing these financial statements, the Company's opening balance sheet was prepared as at April 1, 2017, the Company's date of transition to Ind AS, with the impact of transition being recorded in the opening reserves. Corresponding adjustments pertaining to the comparative previous year as prescribed in the financial results have been restated / reclassified in order to confirm to the current year presentation.
- 3. The Listed Secured Redeemable Non-Convertible Debentures (NCDs) of the Company are secured by way of first and exclusive charge on specified pool of receivables on respective NCDs and *pari-passu* subservient charge on undivided share of Company's immovable property is maintained the minimum asset coverage of hundred percent of issue amount.
- The above results were reviewed by the Audit Committee. The Board of Directors at its Meeting held on October 20, 2019 approved the above results.
