As per press release dated October 04, 2021, Reserve Bank of India (RBI) has stated that it has superseded the Board of Directors of SREI Equipment Finance Limited (SEFL) and SREI Infrastructure Finance Limited (SIFL).

Hon'ble National Company Law Tribunal, Kolkata Bench vide its order no. C.P. (IB) No. 294/2021 and C.P. (IB) No. 295/KB/2021 dated October 08, 2021 admitted the Petition filed by the RBI for commencement of Corporate Insolvency Resolution Process ("CIRP").

Further there shall be moratorium in terms of section 14 of the Code in respect of SEFL and SIFL and the moratorium shall have effect from the date of the order i.e. October 8, 2021 till the completion of the Corporate Insolvency Resolution Process (CIRP) as per the NCLT order.

Vide public announcement dated 11.10.2021, Administrator had called for submission of Claims from the creditors of SREI Equipment Finance Limited ('SEFL')/ SREI Infrastructure Finance Limited ('SIFL') on or before 22.10.2021. In response to the Public Announcement dated 11.10.2019, we acting as Debenture Trustee have filed Claims on behalf of debenture holders in "Form C" - ISIN wise with the Administrator under Regulation 8 of the Insolvency & Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016.
